

MEDICAID BY THE NUMBERS:

Opportunities to Improve Quality and Control Costs

Today Medicaid provides care for over 60 million Americans. With health reform, the program will eventually cover as many as 75-80 million individuals — more than one quarter of all Americans — including many with exceedingly complex and costly health care needs. A closer look at those served by Medicaid reveals significant opportunities to improve care, achieve better health outcomes, and stem increases in national health care spending.

60 million	People in the United States with Medicaid coverage. ¹
\$427 billion	Projected Medicaid spending for FY 2010. ²
1 million	Medicaid beneficiaries resulting from a 1% increase in unemployment; enrollment increased by 5.4% in FY2009 and is projected to increase by 6.6% in FY2010. ⁴
16 - 20 million	Additional Medicaid/CHIP beneficiaries by 2019 due to health reform. ⁵
41%	Births in the United States covered by Medicaid. ⁶
28%	Children in the United States covered by Medicaid. ⁷
50%	Medicaid beneficiaries under 65 who are from diverse racial and ethnic groups. ⁸
25%	Medicaid beneficiaries accounting for nearly 70% of total Medicaid spending. ⁹
5%	Medicaid beneficiaries accounting for 57% of total Medicaid spending. ¹⁰
49%	Medicaid beneficiaries with disabilities diagnosed with mental illness. ¹¹
71%	Medicaid recipients who are enrolled in managed care. ¹²
41%	Total long-term care costs financed by Medicaid. ¹³
94%	Medicaid long-term care beneficiaries in unmanaged fee-for-service. ¹⁴
8.9 million	People who are dually eligible for Medicare and Medicaid. ¹⁵
46%	Percentage of Medicaid dollars spent on dual eligibles. ¹⁶
