

## Community Mapping: Checklist for Behavioral Health and Community-Based Resources Serving At-Risk Adolescents

**HOW TO USE THIS TOOL:** When an adolescent screens as high-risk during a Screening, Brief Intervention, and Referral to Treatment (SBIRT) evaluation, providers may need to connect with behavioral health specialists for next steps. This checklist can be used by health plans and primary care providers as they identify behavioral health and community-based resources serving at-risk adolescents in their community. ☐ Include a list (by zip code) of available, in-network outpatient behavioral health providers and family-based treatment services with a focus on pediatric behavioral health or substance use needs. Indicate providers and services that accept Medicaid reimbursement, those that are in-network for carved-in services, and those that accept only private insurance reimbursement. ☐ Include a list (by region) of community organizations that specialize in youth substance use prevention, including those that use peer groups or peer-to-peer support for youth with substance use needs. ☐ Include a list (by region) of available recovery support services for youth and families. ☐ Include a list (by region) of school-based clinics that have on-site behavioral health resources for youth with substance use needs-☐ Include a list (by region) of youth development community-based programs for at-risk youth (e.g., YMCA, Boys and Girls Club)-☐ Include a list (by region) of relevant social service departments where services can be accessed (e.g., housing, food, transportation). Include a list of national, regional, and community-based informational resources, as well as access portals that support youth and families with behavioral health needs (e.g., Healthify, Health Leads, 211). ☐ Include a list (by plan) of the case management and referral services available for youth

and families.
